

AGRICULTURAL GROUP LOAN AGREEMENT

This loan agreement along with its annexures, applications, addendums and schedules (together known as the "Agreement") is executed at the place and on the date mentioned herein below in favour of UJJIVAN SMALL FINANCE BANK LIMITED, a company incorporated under the provisions of the Companies Act, 2013 (CIN: L65110KA2016PLC142162) and a Banking Company within the meaning of Banking Regulation Act, 1949, with its Registered Office at Grape Garden, No: 27, 3rd "A" Cross 18th Main, 6th Block, Koramangala, Bengaluru, Karnataka - 560095 (hereinafter referred to as "Bank" or "Lender" or "USFB" or "Ujjivan SFB") BY The borrower, whose name, address and other details are set out in the schedule overleaf (hereinafter referred to as the "Borrower", which term shall, unless repugnant to the context, be deemed to include the Co-Borrower(s), if any, as detailed in the Loan Documents). The "Terms and Conditions Governing Agricultural Group Loan Agreement" containing 26 Clauses ("the T&C"), receipt of a copy of which from USFB before execution of this Agreement is confirmed by the Borrower, shall also be deemed as part of this Agreement, and the capitalised terms mentioned herein shall have the same meaning assigned to them in the T&C. Whereas the Borrower has approached USFB for the Borrower's agricultural needs and on the basis of the Application Form and representation from the Borrower, USFB has agreed to lend and to advance to the Borrower, a Loan on the terms and conditions as set out in the Loan Documents. AND WHEREAS, the Co-Borrower(s) agree(s) to secure and, jointly and severally undertake the obligations of the Borrower and co-sign this Agreement.

NOW, THEREFORE, THIS AGREEMENT WITNESSETH AND IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- The Loan shall be governed by the T&C and the terms and conditions contained herein.
- 2. USFB agrees to grant to the Borrower the Loan, not exceeding the amount as se out in the schedule overleaf, for the purpose stated in the schedule overleaf, and the Borrower agrees to avail the Loan.
- 3. The Borrower shall pay Interest at the rate specified in the schedule overleaf in respect of Loan, subject to periodical changes in Interest rates from time to time.
- 4. This Agreement is intended to and shall operate as a continuing security for all loans, indebtedness and liabilities of the Borrower to USFB at all times during the subsistence of the Agreement notwithstanding: (a) The existence of a credit balance or "Nil" balance in any loan accounts of the Borrower at any time or any partial payment or fluctuation of accounts, or (b) Any loans or any part thereof have been repaid either after demand has been made by USFB or otherwise, or has been so repaid on demand.

 USFB is authorised to take recourse of the Remedies provided in the T&C, upon happening of any of the events specified therein.
