A day after the Karnataka government brought its protest to the capital, the Kerala government led by Chief Minister Pinarayi Vijayan hit the Delhi streets on Thursday by staging a protest against the alleged 'discriminatory fiscal policies' of the Centre.

The protest, attended by three chief ministers along with several opposition leaders turned out to be a show of strength of the INDIA bloc ahead of the 2024 general elections. Along with Kerala ministers and MPs, Delhi CM Arvind Kejriwal, DMK Minister Palanivel Thiaga Rajan, CPI leader D Raja, National Conference leader Farooq Abdullah, Kapil Sibal and Punjab CM Bhagwant Mann took part in the stir. which was held at Delhi's Jantar Mantar. However, the main player of the INDIA alliance, Congress, was conspicuous by its absence.

Vijayan said that Kerala's historic battle was aimed at saving the spirit of federalism, Referring to PM Modi's allegations that the protest is to create a narrative of North-South divide, Pi-

COMING down heavily on the GOI's hindrance to borrow for the state's development projects, Stalin said the Union government ought to orchestrate a cohesive strategy to alleviate this fiscal crisis. "The subject of public debt for financing the public expenditure of states is within the exclusive purview of the state legislature as per the Constitution," Stalin said.

Hailing the era of VP Singh as PM as the sentinel of social justice. Stalin said the former PM had assured the then CM, M Karunanidhi, that there would be no need for him to visit Delhi even once for state's

demands. Singh promised that his demands would be fulfilled if he just conveyed them from Tamil Nadu.

"Such respect for states was once a hallmark of our PMs. The current PM, however, perceives states as mere municipalities, showing a marked disdain for the CMs. It deeply disheartens me to witness the deteriorating political climate that necessitates you from Kerala to venture to Delhi for protest," Stalin said.

"Today, a 'black shirt demonstration' was held by DMK MPs in Delhi. All the states are compelled to protest against the common grievance of inequitable distribution of funds. We are rapidly approaching a junc-

ture where the BJP-led Union government will be required to answer for its actions before the people of India," he added.

Deputed to take part in the protest by the CM, Tamil Nadu IT Minister P Thiaga Rajan said the agitation is a fight against unfair, unjust, immoral, and self-destructive depreciation of funds by the GOI at historically unprecedented levels.

"At one time, Tamil Nadu used to get about 70% of its revenue from the Union's share of taxes and 30% on central schemes. Now, we get less than half of the revenues and share of taxes. And central schemes are grossly biased against states like TN," PTR said.
