# GOWDA TEARS INTO SIDDU OVER JDS EXISTENCE REMARKS

No Congress leader can finish off the regional party politically in Karnataka, says JDS supremo

JDS supremo H D Deve Gowda tore into Chief Minister Siddaramaiah for questioning the existence of JDS and said the regional party which is in alliance with the BJP will teach the Ahinda leader a lesson in the upcoming Lok Sabha election.

Addressing JDS workers at Mosalehosahalli in Holenarasipur taluk of Hassan district on Sunday, Gowda said it is not possible for Siddaramaiah or any Congress leader to finish off the JDS politically.

"Siddaramaiah seems to have forgotten that the JDS provided him the steps to grow in politics. There will come a time when JDS leaders will ask the existence of Congress in the nation soon. The party is having presence only in a few states and Karnataka is one among them," he added.

Gowda also said a powerful Congress leader is allegedly collecting the revenue of whole Bengaluru and the money is being spent in neighbouring states to fund party's election campaigns.

He urged the people to insult

Gowda also lauded his son H D Revanna for developing Holenarasipur constituency. "I never rest until my ambitions are fulfilled. Mosalehosahalli will be taluk centre in future for having maximum facilities and good infrastructure," he added. BJP-JDS alliance candidate Prajwal Revanna, Shravanabelagola MLA C N Balakrishna and Hassan MLA Swaroop Prakash spoke on the occasion.

Later, Gowda addressed the poll campaign at Salagame in Hassan assembly constituency where he condemned the decision of Con-

## Bandisiddegowda regrets remarks on HDK's health

A day after a veiled jibe at former chief minister H D Kumaraswamy over his health, Congress MLA representing Srirangapatna Ramesh Babu Bandisiddegowda has expressed his regret over his D Deve Gowda or Kumaraswamy. remark.

Bandisiddegowda had expressed doubts over the recent heart surgery of the JDS leader who is the NDA's choice for the Mandya Lok Sabha constituency, during a party event at Malavalli. The Congress MLA had stated that Kumaraswamy will get himself admitted to a hospital during the elections thereby expressing doubt over the heart procedure.

As his controversial remark upset the party high command, Bandisiddegowda, during an event at Arakere village in Srirangapatna taluk on Sunday, expressed regret and said: "I made the re-

marks on Kumaraswamy's health out of concern over his health and not in bad faith. So, I regret but not apologise for my remark. I appeal to everyone not to continue the issue further. I have never spoken anything bad about the personal issues of former prime minister H As I was in JDS and had good rapport with the family, I expressed my concern over Kumarasawmy's health," he said.

Stating that he had never expressed doubt over the heart surgery, Bandisiddgowda said the controversy is created by the media. Meanwhile, Kumaraswamy visited Sri Adichunchanagiri Mutt in Nagamangala taluk and held special puja to deity Kalabairaveshwara on Sunday morning.

He visited the mutt before launching his election campaign in the constituency. The special puja was performed by mutt seer Nirmalanandanatha Swamji.

# JDS alliance with BJP will strengthen fascist forces, says Dalit activist

VETERAN Dalit activist Guruprasad Keragodu said JDS leader HD Kumaraswamy joining hands with the BJP is a dangerous trend that will further strengthen fascist forces.

He said Prime Minister Narendra Modi's victory in Varanasi and H D Kumraswamy's in Mandya are the same. Kumaraswamy has joined hands to support the dictatorial attitude of Modi who has surrendered the nation's interest to the corporates.

Addressing DSS office-bearers at Kanaka Bhavan, Guruprasad said it's a last attempt to save the democracy. He feared that the return of Modi to office for the third to democracy and Constitution. "The country should not become one more Afghanistan where the Taliban has taken over infringing

the rights of the women and children. The dictatorial attitude of Modi would push the people into trouble," he said.

Gurupraad said that the DSS straight term would pose a threat that had supported the Congress during the assembly elections will continue to back the Grand Old Party in the Lok Sabha elections as well.
