Please be informed that the Nomination and Remuneration Committee of the Board through a resolution passed today on May 13, 2024, has approved a grant of 69,742 options to eligible employees under Bank ESOP Scheme 2019. (Grant 1)

Further, as stated in the Scheme of Amalgamation of Ujjivan Financial Services Limited (Transferor Company) and the Bank (Transferee Company), with respect to the stock options granted to eligible employees by the Transferor Company under its ESOP scheme which remains unexercised upon coming into effect of this Scheme, the Bank shall issue stock options to such eligible employees taking into account the share exchange ratio and on the same terms and conditions. Accordingly, the Committee has granted 28,48,007 options to such eligible employees under its Bank ESOP Scheme 2019. (Grant 2)
