#### Sub: Outcome of the meeting of the Board of Directors held on March 05, 2025

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform that, the Board of Directors of the Bank, in its meeting held today on March 05, 2025, has inter alia approved the following:

a) Re-appointment of Ms. Sudha Suresh (DIN: 06480567), as an Independent Director of the Bank for a second term starting from April 01, 2025 and upto August 19, 2029 (the date when she will complete the maximum tenure of 8 years on the Board of the Bank, as permitted by the RBI) subject to the approval of the shareholders.

With reference to NSE Circular - NSE/CML/2018/02 dated June 20, 2018, we affirm that Ms. Sudha Suresh is not debarred from holding the office of director by virtue of any SEBI order or any other such authority.

b) Re-appointment of Ms. Anita Ramachandran (DIN: 00118188), as an Independent Director of the Bank for a second term starting from July 01, 2025 and upto April 27, 2030 (*she turns seventy-five years of age on April 28, 2030, which is the upper age limit for Director on the Board of a Bank*) subject to the approval of the shareholders.

With reference to NSE Circular - NSE/CML/2018/02 dated June 20, 2018, we affirm that Ms. Anita Ramachandran is not debarred from holding the office of director by virtue of any SEBI order or any other such authority.
