Veer Balidani Sub Inspector Sawant Singh 3-7-1940 To 2-7-1975

Sub Inspector Sawant Singh of 44 Battalion was deployed for anti-Naxal duties. On 2 July 1975, following the killing of eight extremists near Patna by Bihar Police, his company was rushing

reinforcements when it was ambushed by Naxals. In the ensuing firefight, Sub Inspector Sawant Singh fought valiantly but was fatally hit, making the supreme sacrifice in the line of duty. In recognition of his exceptional courage and valour, he was posthumously awarded the President's Police Medal for Gallantry.

Veer Balidani Sardara Singh 7-7-1942 To 2-7-1992

113 Battalion of CRPF was deployed in Gujarat to maintain law and order during the 1992 Jagannath Rathyatra and Moharram. As communal tensions escalated from 1 July, troops took preventive measures.

On 2 July, a violent clash erupted between two groups. While pacifying the mob, Inspector Sardara Singh sustained grievous injuries. Undeterred, he continued his duty and succeeded in calming the situation, but laid down his life in the line of duty.


On 27 June 2002, troops of 48 Battalion were deployed at Raghunath Mandir, Anantnag to deter militant activity. A team visiting Lal Chowk to purchase condiments was targeted with a grenade, which

exploded amidst the crowded area, injuring four personnel. Due to the dense civilian presence and unknown source of attack, retaliatory fire was not feasible. The injured, including gravely wounded Head Constable Ajay Kumar Singh, were evacuated to 92 Base Hospital, where Head Constable Singh succumbed to his injuries on 2 July 2002, attaining martyrdom.
